

FACT SHEET STUDENT EXCHANGES AT MCGILL'S FACULTY OF LAW 2023-2024

Exchange Application Due Date

Fall 2023 and Full-year exchange deadlines:

Nomination deadline: April 14, 2023

Student supporting document deadline: May 1, 2023

Winter 2024 exchange deadlines*:

Nomination deadline: August 14, 2023

Student application deadline: August 14, 2023

Student supporting document deadline: September 1, 2023

We cannot guarantee that applications will be accepted beyond these dates. If you encounter difficulties in submitting the applications within the deadline, please contact sao.law@mcgill.ca prior to April 14, 2023, for Fall 2023 and Full-year exchanges, and prior to August 14, 2023, for Winter 2024 exchanges.

*Note about Winter 2024 exchange deadlines: registration for both Fall 2023 and Winter 2024 courses open mid-July 2023 for all newly-admitted Fall 2023, Full-year and Winter 2024 exchange students. Therefore, *if possible*, we recommend that Winter 2024 applications are submitted before that date so that Winter term exchange students will be able to start registering for their courses along with other newly-admitted exchange students in June.

Minimum Academic Requirements

- Must be in good standing and have completed at least one full academic year in a University (law program) by the time you go abroad
- Cumulative CGPA of 3.00 (B average) is required for consideration

Bilingual Language Policy

McGill's Law program is offered in a bilingual, English & French, environment. The majority of courses at McGill are offered in English, thus the ability to communicate in English is a requirement.

At the Faculty of Law, reading of complex substantive texts in French and English are assigned in many upper-year law courses, irrespective of the language of instruction of the course. In certain courses in particular, such as private law courses, students will be assigned readings in French. While examination questions are set in the language in which a course is given, any examination may contain extensive passages in either French or English. Students should take this into account when selecting courses and are welcome to contact Faculty advisors if they have any questions or concerns.

In order to communicate fully with all law students at McGill, and to understand all course materials, the ability to speak and read French is an asset.

Orientation

Faculty of Law: The Law Faculty organizes orientation information sessions for all newly-admitted exchange students. The session for Fall term and full-year exchange students takes place in late August/early September. The session for newly-admitted Winter term exchange students will take place in January.

International Student Services Office: McGill's International Student Services Office hosts webinar information sessions on their website prior to arrival at McGill so that students can learn more about McGill, Montreal, Study Permits, Health Insurance, Housing, Banking, Cell phone plans, Orientation, and more. Course Registration

- Exchange students may start registering for courses on Minerva, for both terms, mid-July 2023.
- Law course information, including course offerings and examination timetables, can be found on the Faculty of Law's website https://www.mcgill.ca/law-studies/courses/current (updated each year in May).
- To maintain full-time status, students are required to take 12-15 credits per term. Incoming Exchange students can register to any of our courses **EXCEPT** for 1st year (1L) and 2nd year (2L) required courses, Moots, Clerkships, Legal Clinics, Group Assistant and Term Essays.
- Please note that courses may be added or cancelled and changes may be made throughout the academic year. Please also note that we cannot guarantee that the same courses will be offered in the same terms in future academic years.
- Students may register in most upper-year undergraduate law courses, as long as there is space and they have taken the equivalent of the prerequisite(s) for the course. Incoming exchange students are also permitted to register for graduate-level law courses, and a maximum of 2 non-law courses per term (max 6 credits), upon approval and availability. Please note that some courses may be full as priority is usually given to our Law students upon early registration.


