- 1. The Committee established its quorum (Article 5, Clause 4).
- 2. The Committee confirmed that four applications for the allocation of starter flats had been received by the RUK by the due date (25.10.2024) and subsequently submitted to the Committee for consideration (in the order of the date submitted). These applicants are:
 - **Sybren Heyndels, Ph.D**. (AP2 at the Faculty of Arts from 1 October 2024)
 - **Subhasmita Ray, Ph.D.** (VP2 at Faculty of Mathematics and Physics from 15.3.2024)
 - **Ernest Gyan Bediko, Ph.D.** (VP2 at Faculty of Mathematics and Physics from 1.8.2024)
 - Mgr. Michaela Kousalová (AP1 at Faculty of Social Sciences from 12.11.2024)
- 3. The Committee stated that its task is to discuss and award the occupation of 2 starter flats, designated as No. 1442 and No. 1443.
- 4. The Committee proceeded to check the conditions for the allocation of a starter flat for individual applications, as stipulated in Article 2 of the Rules for Allocation of Starter Flats at Charles University (Rector's Directive No. 4/2022).
- 5. Based on the findings, the Committee has established the following:
 - a. Sybren Heyndels, Ph.D. (meets the conditions)
 - b. Subhasmita Ray, Ph.D. (meets the conditions)
 - c. Ernest Gyan Bediko, Ph.D. (meets the conditions)
 - d. Mgr. Michaela Kousalová (does not meet the conditions, exceeds the age limit by 23 days as per RD No. 24/2022 and requests an exception in this respect)
- 6. Based on these findings and considering the applicants' situation (cohabitation with a partner, allowing cohabitation with a pregnant spouse), the committee **recommends** accepting the application of Dr. Ernest Gyan Bediko and assigning him the vacant starter flat No. 1442, which he will occupy together with his wife and expected child. It also **recommends accepting the application of Dr Sybren Heyndels** and assigning him the vacant starter flat No 1443, which he will occupy with his partner.
