**Requirements as of the anticipated start date:**

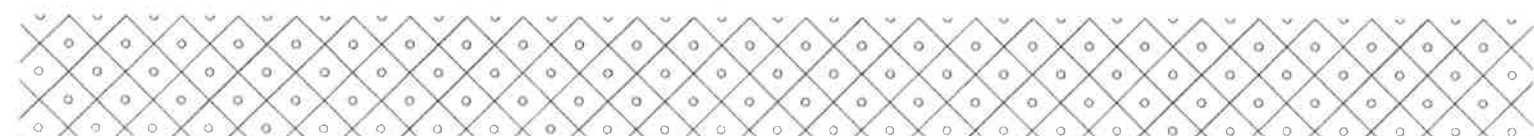
- Master's degree in Law; research degree (Ph.D., CSc., Dr.);
- Appointment as Associate Professor or Full Professor in Constitutional Law, or at least initiated proceedings for such appointment in Financial Law is an advantage;
- At least 7 years' professional experience in Financial Law;
- Teaching and research activity in Financial Law;
- Active command of one major foreign language; knowledge of a second foreign language is an advantage;
- No concurrent employment exceeding 20 hours per week, or a commitment to reduce or terminate such employment in the event of a successful application;
- Publication record in Financial Law;
- Publications in international journals with an Impact Factor are an advantage;
- Active participation in national or international academic conferences;
- Experience in the preparation, acquisition, and investigation of research grant projects is an advantage;
- Membership of relevant national and international professional organisations is an advantage.

- Professional *curriculum vitae*;
- Evidence of completed higher education and awarded research degrees (only in cases where the education or degrees were not obtained at Charles University);
